

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://www.mgcoaching.online>, and MG Coaching and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to MG Coaching include <https://www.mgcoaching.online>, MG Coaching, MG Coaching and [www.mgcoaching.online](https://www.mgcoaching.online). The MG Coaching website is a Personal/Professional Coaching & Social Services site. By using the MG Coaching website, you consent to the data practices described in this statement.

## **Collection of your Personal Information**

In order to better provide you with products and services offered, MG Coaching may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Financial Information (If Applicable)

If you purchase MG Coaching's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.
